### **Release and Waiver of Liability**

**PLEASE READ CAREFULLY! THIS IS A LEGAL DOCUMENT THAT AFFECTS YOUR LEGAL RIGHTS!**

The Volunteer desires to work as a volunteer for **California Zoroastrian Center** and engage in the activities related to being a volunteer for \_\_\_\_\_ (the "Activities"). The Volunteer understands that these Activities may include **risk of serious injury or harm from people or objects participating in the Activities including, but not limited to, setting up and breaking down the event, lifting and transporting heavy items, refereeing and officiating or any similar activities required for the Activity, as well as transportation to and from the work sites. THIS IS NOTICE TO THE VOLUNTEER of potentially hazardous conditions, or other circumstances that may result in personal injuries.**

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

1. **Release and Waiver.** Volunteer does hereby release and forever discharge and hold harmless **California Zoroastrian Center** and its successors and assigns from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, that arise or may hereafter arise from Volunteer's Activities with **California Zoroastrian Center**.

VOLUNTEER UNDERSTANDS THAT THIS RELEASE DISCHARGES CALIFORNIA ZOROASTRIAN CENTER FROM ANY LIABILITY OR CLAIM THAT THE VOLUNTEER MAY HAVE AGAINST CALIFORNIA ZOROASTRIAN CENTER WITH RESPECT TO ANY BODILY INJURY, PERSONAL INJURY, ILLNESS, DEATH, OR PROPERTY DAMAGE THAT MAY RESULT FROM VOLUNTEER'S ACTIVITIES WITH CALIFORNIA ZOROASTRIAN CENTER WHETHER CAUSED BY THE NEGLIGENCE OF CALIFORNIA ZOROASTRIAN CENTER OR ITS OFFICERS, DIRECTORS, EMPLOYEES, OR AGENTS OR OTHERWISE. VOLUNTEER ALSO UNDERSTANDS THAT CALIFORNIA ZOROASTRIAN CENTER DOES NOT ASSUME ANY RESPONSIBILITY FOR OR OBLIGATION TO PROVIDE FINANCIAL ASSISTANCE OR OTHER ASSISTANCE, INCLUDING BUT NOT LIMITED TO MEDICAL, HEALTH, OR DISABILITY INSURANCE IN THE EVENT OF INJURY OR ILLNESS.

2. **Medical Treatment.** Volunteer does hereby release and forever discharge California Zoroastrian Center from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with **California Zoroastrian Center.**

3. **Assumption of the Risk.** The Volunteer understands that the Activities may involve work that may be hazardous to the Volunteer, including, but not limited to, setting up and breaking down the event, **lifting and transporting heavy items, refereeing and officiating** or any similar activities required for sporting events, as well as transportation to and from the work sites. Volunteer hereby expressly and specifically assumes the risk of injury or harm in the Activities, and releases **California Zoroastrian Center** from all liability for injury, illness, death, or property damage resulting from the Activities.

4. **Insurance.** The Volunteer understands that, except as otherwise agreed to by **California Zoroastrian Center** in writing, **California Zoroastrian Center** does not carry or maintain health, medical, or disability insurance coverage for any Volunteer. **Each Volunteer is expected and encouraged to obtain his or her own medical or health insurance coverage.**

5. **Photographic Release.** Volunteer does hereby grant and convey unto **California Zoroastrian Center** all right, title, and interest in any and all photographic images and video or audio recordings made by **California Zoroastrian Center** during the Volunteer's Activities with **California Zoroastrian Center**, including, but not limited to, any royalties, proceeds, or other benefits derived from such photographs or recordings.

6. **Other.** Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of California and that this Release shall be governed by and interpreted in accordance with the laws of the State of **California.** Volunteer also agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
